# Notice to Sailors Hazard to Navigation

All sailors, coaches, and parents are hereby notified of an underwater hazard to navigation in the waters immediately off the Shore Acres Yacht Club launch beach. This hazard was installed in the Fall of 2007 and is defined as a Geo-tube intended to reduce beach erosion of the Club property. The Geo-tube is a large circular tube filled with sand. The dimensions and location of the Geo-tube are shown in the diagrams below. The Geo-tube is marked by stakes, buoys, and floats. All navigators are required to round the Geo-tube's western end. If failure to obey this notice results in damage to the Geo-tube, damage to the navigator's own water craft, or any personal injuries, the navigator will assume responsibility.
